# The 29<sup>th</sup> July, 2005

NO. G.S.R.9/Const./Art.309/2005- In exercise of the powers conferred by the provisio to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules to further amend the Haryana Education (College Cadre) Group A Service Rules, 1986, namely:-

1. These rules may be called the Haryana Education Directorate (College Cadre) Group A Service (Amendment) Rules, 2005.

2. In the Haryana Education (College Cadre) Group A Service Rules, 1986, (hereinafter called the said rules), for Rule 5, the following rule shall be substituted, namely :-

"5. Age – No person shall be appointed to any post in the Service by direct recruitment who is less than thirty-six years of age on or before the  $15^{\text{th}}$  day of the month preceding the last date of submission of applications to the Commission.

3. In the said rules, in rule 9, in sub-rule (1), for clause (b), the following clause shall be substituted, namely: -

- "b) in case of Deputy Director Colleges/Principals of Colleges and Colleges of Education.
  - (i) 25% by direct recruitment; and
  - (ii) 75% by promotion from amongst college lecturers;

Provided that the Government may, in case suitable candidates for the posts of Deputy Director Colleges/Principals of Colleges and Colleges of Education are not available by direct recruitment, fill in any post by transfer or deputation from amongst the Deputy Director Colleges/Principals of Colleges and Colleges of Education already in the service of Government of India or any other State Government or the University."

4. In the said rules, in Appendix B, under columns 1, 2, 3 and 4 for serial number 2 and entries thereagainst, the following serial number and entries thereagainst shall be substituted, namely: -

- "2 Deputy Director Colleges/ Principal of Colleges and Colleges of Education.

- a) A Master's Degree with at least 55% marks or its equivalent grade of B in the 7 point scale latter grades O,A,B,C,D,E and F.
- b) Ph.D or equivalent published work.
- c) Total experience of 15 years of teaching/Research in Universities/Colleges and/other institutions of Higher Education.
- d) Knowledge of Hindi up Matric to or its equivalent.

Besides above said qualifications M.Ed degree is essential in case of Principals of Colleges of Education.

Note :-

- Caste/ Scheduled Tribes candidates who have passed their Master's degree relaxation of 5% in the minimum requirements of marks percentage shall be granted.
- (ii) B and C in the 7 point scale with letter grades O, A, B, C, D, E and F shall be regarded as equivalent of 55% and respectively 50% wherever the grading system is followed.

- (a) Total experience of 15 years of Teaching/Research in Universities/Colleges as lecturers and/or other institutions of Higher Education.
- (b) Knowledge of Hindi up to Matric or its equivalent.

Besides above said qualifications M.Ed degree is essential in case of Principals of Colleges of Education.

Note:-

(i) In case of Scheduled The minimum requirement of 55% and condition of Ph.D or equivalent published work shall not be insisted upon for the existing incumbents who are already in the university system.

(iii) The minimum requirement of 55% shall not be insisted upon the Principal, for the existing incumbents who are already in the university system. However, these marks should be insisted upon for those entering the system from outside and those at the entry point of lecturers.
