Scheme of Revision of Pay of teachers and equivalent cadres in Universities and colleges following the revision of pay scales of Central Government employees on the recommendations of the 7th Central Pay Commission (CPC).

In continuation of this office Memo No. 7/79-2017C-IV(3) dated 08.09.2019 to the subject cited above.

I have been directed to inform you that, the pay scale of teachers and equivalent cadres were revised on the basis of MHRD notification dated 02.11.2017 adopted by UGC vide letter dated 31.01.2018 and ICAR Notification 1(4)/2017-Per.IV dated 27.03.2018. Thereafter, vide notification dated 08.11.2017 issued by MHRD in continuation of notification No. 1-7/2015-U.II(1) dated 02.11.2017, following changes have been made in the Academic Level-12, 13A and 14 in the table appended to the notification:-


Cell Academic Level 12, row 3 may be read as "84700" instead of "84100"

Cell Academic Level 13A, row 16 may be read as "204700" instead of "204100"

Cell Academic Level 14 row 9 may be read as "182700" instead of "182100".

Therefore, it is requested to take action accordingly.
