

1.	a) Sitting fee for attending Board meetings of the concerned organization. b) Sitting fee for attending meetings other than Board meetings.	Rs. 3000/- Rs. 1500/-
2.	TA/DA	As admissible to Grade-1 officers of State Government as per the instructions issued by Finance Department vide No. 5/27/98-1FR (FD) dated 20.06.2018 pertaining to admissibility of Travelling Allowance, Daily Allowance, Travelling Entitlement.

These instructions shall apply in all cases where there is no provision in any governing Act and/or Rules/Regulations framed under the Act on the matters covered in these instructions. Where any such provisions exist, the same shall override these instructions. Where any Act mandates the terms and conditions to be prescribed by Rules, the Administrative Department will ensure that terms and conditions are fixed in accordance with such Rules only. Where such Rules have not yet been framed, the Administrative Departments are requested to frame these immediately.

3. These instructions issue with the concurrence of the Finance Department conveyed vide their Number 1931/HBPE (FD) 2019, dated 12-03-2019. **These shall come into force with immediate effect.**




