



No. 2/9/2017-1 Pension.- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules further to amend the **Haryana Civil Services (Judicial Branch) and the Haryana Superior Judicial Service (Revised Pension) Part-I Rules, 2011**, namely:-

1. These rules may be called the **Haryana Civil Services (Judicial Branch) and the Haryana Superior Judicial Service (Revised Pension) Part-I (Amendment) Rules, 2018.**

2. In the Haryana Civil Services (Judicial Branch) and the Haryana Superior Judicial Service (Revised Pension) Part-I Rules, 2011, in clause (iv) of sub-rule (1) of rule 5,-

- (i) in the existing proviso for the sign “.”, the sign “:” shall be substituted; and
- (ii) after the existing proviso, the following proviso shall be inserted, namely:-

“Provided that the Judicial Officers who retired between 1st January, 1996 and 31st December, 2005, their pension shall now be revised by raising the same by 03.07 times with effect from the 1st January, 2006.”

संख्या 2/9/2017-1 पेंशन- भारत के संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, हरियाणा के राज्यपाल, इसके द्वारा, हरियाणा सिविल सेवाएं (न्यायिक शाखा) तथा हरियाणा वरिष्ठ न्यायिक सेवा (पुनरीक्षित पेंशन) भाग-1 नियम 2011, को आगे संशोधित करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात् :-

- 1 ये नियम हरियाणा सिविल सेवाएं (न्यायिक शाखा) तथा हरियाणा वरिष्ठ न्यायिक सेवा (पुनरीक्षित पेंशन) भाग-1 (संशोधन) नियम, 2018, कहे जा सकते हैं।
- 2 हरियाणा सिविल सेवाएं (न्यायिक शाखा) तथा हरियाणा वरिष्ठ न्यायिक सेवा (पुनरीक्षित पेंशन) भाग-1 नियम 2011 में, नियम 5 में, उपनियम (1) में, खण्ड (iv) में,-

(i) परन्तुक में, अन्त में, विद्यमान "।" के स्थान पर, ":" चिह्न प्रतिस्थापित किया जाएगा; तथा

(ii) विद्यमान परन्तुक के बाद, निम्नलिखित परन्तुक रखा जाएगा, अर्थात् :-

"परन्तु यह और कि न्यायिक अधिकारियों, जो प्रथम जनवरी, 1996 तथा 31 दिसम्बर, 2005 के बीच सेवा निवृत्त हुए हैं, की पेंशन को 3.07 से गुणा करते हुए प्रथम जनवरी, 2006 से पुनरीक्षित किया जाएगा।"
