

No. 16/27-2017-4Pro:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following amendment in the Haryana Government, General Administration Department (Protocol Branch) notification No. 16/27/2017-4Pro dated 16<sup>th</sup> April, 2018, namely.

**Amendment**

In the Haryana Government, General Administration Department (Protocol Branch), notification No. 16/27/2017-4Protocol, the following amendment are made:- Para 3 (a) amended as :

"This scheme will be applicable to residents of Haryana who participated actively and struggled during the period of emergency and faced imprisonment even for one day. The scheme will cover all such residents of Haryana whether they were detained under MISA 1971, Defence of India Act, 1962 or under the preventive provisions of Sections 107/151 etc. of the Criminal Procedure, code 1973."

Para 4 (i) and Para 4(k) shall be deleted

संख्या 16/27/2017-4प्रो0- भारत के संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, हरियाणा के राज्यपाल, इसके द्वारा हरियाणा सरकार, सामान्य प्रशासन विभाग (प्रोटोकॉल शाखा) की अधिसूचना संख्या 16/27/2017-4प्रो0 दिनांक 16 अप्रैल, 2018 में निम्न संशोधन करते हैं, अर्थात् :-

**संशोधन**

हरियाणा सरकार, सामान्य प्रशासन विभाग (प्रोटोकॉल शाखा) अधिसूचना संख्या 16/27/2017-4प्रो0, दिनांक 16 अप्रैल, 2018 में, पैरा 3 में, खण्ड (क) के स्थान पर निम्नलिखित खण्ड प्रतिस्थापित किया जाएगा, अर्थात् :-

पैरा 3 के शीर्ष (क) :

“यह स्कीम हरियाणा के ऐसे निवासियों के लिए लागू होंगी, जिन्होंने आपातकाल की अवधि के दौरान सक्रिय रूप से भाग लिया और संघर्ष किया तथा चाहे उन्हें एम0आई0एस0ए0 अधिनियम, 1971 और/या भारत के प्रतिरक्षा अधिनियम, 1962 के अर्न्तगत या 107/151 सी.आर.पी.सी. 1973 के तहत बनाये गये नियमों के अनुसार चाहे एक दिन के लिए ही कारावास जाना पड़ा हो। ये योजना ऐसे व्यक्तियों की विधवाओं के लिए भी लागू होंगी”।

पैरा-4 (झ) तथा (ट) में वर्णित शर्त को हटाया जाएगा।
