



the financial year 2018-2019 at the rates given below:-



2. In case of mis-utilization of any loan, penal interest @10% per annum will be charged from the
applicant over and above normal rate of interest.

3. It has also been decided to fix the rate of interest at 7.6% per annum on deposits in the General
Provident Fund and other similar funds w.e.f. 18th July,2018 to 30th September,2018.
