


It is observed that time and again complaints are being received in general that a number of Govt. house are lying vacant but not being included in Bid by the concerned authorities. Some houses are subletted by its allottees to un-authorized persons. As such, it has been decided by the Chandigarh Administration to make door-to-door checking/survey of all the Government House of each type w.e.f. 1<sup>st</sup> September, 2018 by checking/verifying their Aadhar Card/e-mail address/date of birth/present designation and present place of posting etc. to ascertain the authenticity of the allottees.

You are therefore, requested to direct the employees of various departments to co-operate with the Checking Teams. This has been issued with the approval of H.E. the Administrator, U.T., Chandigarh.






