

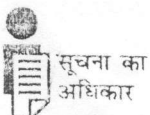
4. I shall be grateful if you could arrange to send proposals under State Collaboration Initiative Scheme from your State at an early date.
