



Subject:- Recommendations made during DGsP/IGsP Conference, 2018 held on December 20-22, 2018 at Kevadiya, Gujrat.

I am directed to refer to the subject noted above and to inform you that on the recommendations made during the last Director Generals of Police/Inspector Generals of Police Conference, 2018, the Government has decided that Police Officers using the same set of witnesses in "Panchnamas", even after transfer elsewhere, should be identified. It should be ensured that no person becomes a witness in "Panchnamas" more than once. This may be ensured by recording the Aadhar number of the witness, as this would ensure genuine witness and remove loopholes in the system. It has also been decided that Government employees may be associated as witnesses in all planned search & Seizure operations. As the Government employees are likely to co-operate with the police authorities, efforts may be made to associated them as witnesses, as and when required.

2. The above instructions be brought to the notice of all the concerned for compliance.
