I am directed to refer to this department letter No. 40/4/2018-4 Pol dated 26.04.2019 on the subject noted above and to say that Lokayukta, Haryana has drawn attention of the State Government towards the provision of the Haryana Lokayukta Act-2002, Section 17(2) which is as under:-

"the competent authority shall cause the report to be examined and communicate to the Lokayukta within three months of the date of receipt of the report, the action taken thereon."

2. It has been observed by the Lokayukta, Haryana that on the recommendations of Lokayukta, Action Taken Reports are not submitted as per the provision of the Act. Action Taken Reports are being sent by the various officers to the office of Lokayukta directly in a casual manner. To curb the tendency of sending the action taken reports in casual manner, the Government has decided that it shall be ensured in future that the action taken reports would be communicated to Lokayukta through competent authority, as per the provisions of the Act. As per the Haryana Lokayukta Act 2002 Competent Authority in relation to a complaint against all other Public Servants is the Chief Minister.

3. It is, therefore, requested to ensure compliance of the provisions of Haryana Lokayukta, Act 2002, under intimation to this department.
