Sub: Instructions regarding engagement of extension lecturers & compliance of orders of the State government.

May please peruse the subject cited above.

I have been directed to inform you that in continuation to this office vide letter dated 20.09.2019 and vide memo No. 4/36-2010 C1(5) dated 16.09.2019 directions were issued to all the Principals w.r.t engaging the "Displaced Extension Lecturers" wherein it was clearly mentioned about "Displaced extension lecturer".

Aa Public notice was also given by the department in national dailies wherein the petitioners who are claiming to be Extension Lecturers have been given personal hearing on 26th and 27th September, 2019 (at Department of Higher Education, Haryana, Panchkula) in light of the directions of Hon'ble High in a bunch of CWP's Nos. viz., 16931 of 2019(O&M), 20840, 15763, 16937, 17266, 17379, 17486, 16931, 18358, 19049, 19201, 19202, 19212, 19351, 16353, 17783, 17787, 19787 of 2019 and some other similar Civil Writ Petitions, wherein the Hon'ble Punjab and Haryana High Court has disposed of the CWP's 16931 and other CWP's with the directions reiterated as under:-

"In order to avoid impasse, I deem it appropriate to dispose of writ petitions with direction to respondents to decide representations of petitioners and pass a speaking order thereon after affording opportunity of hearing within a period of two months after admission process is over. In case no representation is given till date, liberty is granted to submit appropriate application/representation within a period of one week from the date of receipt of certified copy of this order. If decision is not taken by concerned respondent to whom representation is made as directed by this Court, it will entail into imposition of costs of `25,000/- to be paid to petitioner(s) from salary of officer/official found responsible for not deciding representation. This condition of imposing costs is only to prevent petitioner(s) to run from pillar to post and avail remedy of contempt in case of non-compliance of directions issued by this Court."

There are also some similar directions in other civil writ petitions w.r.t. those incumbents who claimed to have worked as extension lecturers in various Govt. Colleges.

In light of all such directions given by Hon'ble Punjab and Haryana High Court, all those petitioners/ similar claimants, who claims to be the displaced "Extension lecturer" **are hereby given the chance of to be heard in person on 26th and 27th September, 2019 from 10.30 a.m.** onwards in the Conference room, O/o Director Higher Education, Haryana, Shiksha Sadan, sector-5, Panchkula.

Further, in some of the Civil Writ petitions the necessary action is to be taken at the level of Principal of the concerned Government College being the respondent. Therefore, keeping in view of such directions it is hereby directed that the Principals of the districts **Ambala, Bhiwani, Charkhi dadri, Fatehabad, Faridabad, Gurugram, Hisar, Jhajjar, Kurukshetra, Karnal, Mohindergarh, Panipat and Panchkula will also reach this office on 26.09.2019 at 9.30 a.m. without fail and for rest of the district's the officer next to the Principal will attend this office and all will give personal hearings to the petitioners.**

Similarly, on 27th September, 2019 the Principals of the districts(where in the officer next to the Principal have attended this office on 26th September, 2019) will be coming to this office and the officer next to the Principal of districts **Ambala, Bhiwani, Charkhi dadri, Fatehabad, Faridabad, Gurugram, Hisar, Jhajjar, Kurukshetra, Karnal, Mohindergarh, Panipat and Panchkula will attend this office at 9.30 a.m. and all will give personal hearings to the petitioners.**

However, it is made clear that the Principals of Government Colleges which came into existence and started academic work in 2018-19 and 2019-20 **have NOT to attend this office on 26 & 27th September, 2019, provided that in no case these colleges are not mentioned in any of the CWP's as respondents.**

Please ensure strict compliance of these directions and no exemptions may be granted to the Principals/ officers next to the Principal..
