





Sir/Madam,

I am directed to refer to the subject noted above and to say that Principal Secretary, Election Commission of India vide letter no. 437/6/INST/ECI/FUNCT/MCC/2019 dated 20.8.2019 has intimated that a reference has been received in Commission from Chief Electoral Officer, Maharashtra, seeking clarification on a cut-off date to consider prior to 31.10.2017 for regulation of posting/transfer of officer in relation to the upcoming Assembly elections. Accordingly the matter has been considered by the Commission and it is clarified that the crucial period for the purpose of the transfer/posting relates to General/ Bye election held in Assembly during the period from 01.11.2015 to 31.10.2017. Therefore, for calculating period of 3 years out of 4 years, it is not required to go beyond/ before 01.11.2015.
