

It is intimated that National Testing Agency (NTA) has fixed the written exam (OMR Based) for Common Eligibility Test (CET)-2022, Haryana for Group-C posts on behalf of Haryana Staff Selection Commission at District H.Q. and Sub-Divisions on 05.11.2022 & 6.11.2022 (Morning & Evening Session) (7.11.2022 as a reserve day for exigency) in various Schools, Colleges, Educational Institutes and Technical Institutes of 17 Districts (list attached). However, it has been observed that 5th November (Saturday) is working day.
