Whereas Sh. Jagmohinder Singh Rana & Others working as Assistant/Associate Professor in Govt. Colleges of Haryana had filed a Civil Writ Petition No. 8429 of 2014 in the Hon'ble Punjab & Haryana High Court whereby the Hon'ble High Court disposed of the said writ petition vide its order/judgment dated 05.05.2014 with the following observations:-

"...In view of the statement made by the counsel for the petitioners and without going into the merit of the case or commenting thereon, the present writ petition is disposed of with liberty to the petitioners to file a detailed representation to Financial Commissioner and Principal Secretary to Govt. of Haryana respondent No. 1 within a period of 3 weeks from today. If such a representation is filed within the stipulated period, the same shall be considered and decided by said respondent No. 1 within a period of 3 months from the date of receipt of certified copy of this order.

In case the claim of the petitioners is accepted, the consequential benefits, if any, be released to them, in accordance with law, within a further period of one month. In case the claim of the petitioners is not to be accepted, then a well reasoned and speaking order be passed and conveyed to the petitioners forthwith. "

- Whereas in view of the above judgment, the petitioners filed their representations. 2. The main submissions of their representations are as under:-
 - 1. They are employees of Govt. of Haryana and are governed by Civil Service Rules as applicable in Haryana. It is also pertinent to mention here that as per the terms and conditions of their appointment letters it has been clearly mentioned that in all the matters they will be governed by the Punjab Civil Service Rules as applicable to Haryana Govt. employees and as such orders/instructions as may be issued by the Govt. time to time.
 - 2. "..Re-fix their pay keeping in view the letter/orders dated 16.4.12 of Finance Department, Govt. of Haryana as in the similar situated cases of University employees of the state who are also governed by the UGC and they are also taking/getting the benefits arising out from the letter/orders dated 16.4.12."
- Whereas it is a admitted fact that the Assistant/Associate Professors working in 3. Govt. Colleges are governed by Civil Services Rules as applicable in Haryana but vide notification No. KW 7/18-2009C-IV(3) dated 21-07-2011 the State Govt. adopted the recommendations of the UGC and MHRD with regard to pay scales and in other matters for the maintenance of the standard of Higher Education. Accordingly, the Assistant/Associate Professors working in Govt. Colleges are getting UGC pay scale w.e.f. 01-01-2006.



4. Whereas regarding additional increment in view of the letter/orders dated 16-04-2012 of the Finance Department, Govt. of Haryana is concerned, the opinion/concurrence of the Finance Department has been sought and the Finance Department, Haryana has observed as under:-

"As per UGC recommendations dated 20.11.2013 there is no provision for grant of one increment w.e.f. 01.01.2006 to those, whose increments was due between February to June, 2006 and F.D letter dated 16.04.2012 issued by State Govt. is not applicable to the petitioners.

In view of the position explained above and letter dated 20.11.2013 (Copy of the letter is attached herewith) issued by UGC, it is evident that the claim of the petitioners is not covered under UGC guidelines. Hence, the demand of the petitioners to grant additional increment is not acceptable being devoid of merit and accordingly the representations of the petitioners are rejected.

I order accordingly.
