

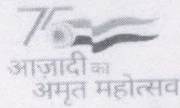

Dear Chief Secretary,

Graduate Aptitude Test in Engineering (GATE) 2024 and Joint Admission Test for Admission for Masters (JAM) 2024 will be held nation-wide in nearly 602 centres spanning 222 cities. About 8.24 Lakh candidates will be appearing for GATE 2024 and about eighty thousand will be appearing for JAM 2024. IISc Bengaluru and IIT Madras are the organizing institutes for these examinations respectively. The dates for these examinations are as follows:

GATE 2024: February 3,4,10 and 11, 2024
JAM 2024: February 10 and 11, 2024
Mock Tests: February 2 and 9, 2024

- The Institute Representatives (IRs) from IISc and IITs will be travelling to the centres in various cities to conduct the exam and oversee various operations related to the exam. The IRs will carry an official authorization letter from their respective institutions certifying their role in the examinations.
- In the event of a Covid-like situation or similar unforeseen circumstance, this authorization letter may be treated as a curfew-pass to enable the IRs to move freely to ensure smooth conduct of the examination.

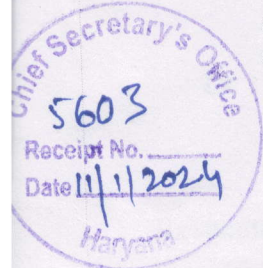
