

Subject: Online filling of Annual Property Returns.

Sir/Madam

I am directed to invite your kind attention to the Government letter of even number dated 18.08.2022 on the subject noted above, vide which it has been directed to charge-sheet the those officers/officials of Group A, B & C who have not filed/upload their Annual Property Return for the last two years or more.

2. Now, the State Government has taken a lenient view and it has been decided to grant last opportunity to all officers/officials of Group A, B & C to file their Annual Property Return on HRMS portal up to 31.10.2022. The site for filing the property return is <http://intraahry.gov.in>. However, the deadline for the submission of online Annual Property Returns will be remained unchanged i.e. 30th April of every Financial Year in future. It has also been decided not to charge sheet any officer/official till 31.10.2022 on account of non filling of Annual Property Returns and instructions issued vide even number dated 18.08.2022 may be kept abeyance till 31.10.2022.

3. These instructions may be brought to the notice of all concerned to ensure for compliance in letter and spirit.
