It is intimated that the above said matter was listed for hearing on 17.07.2023 and the Hon'ble Commission while taking serious view on the issue, has pleased to pass the order dated 17.7.2023 (Copy Enclosed). Therefore, you are hereby directed to prepare roaster register and get the roaster verified from the special constituted committee under the Chairmanship of Additional Director, Department of Social Justice, Empowerment, Welfare of Scheduled Castes and Backward Classes and Antyodaya (SEWA) and to calculate the backlog w.e.f. 1.1.1996 till 18.4.2017 as per PWD Act, 1995 and 4% thereafter in accordance with Section 34 of RPwD, Act, 2016, at the earliest, i.e. most preferably within one week from the date of issuance of this communication. It is further directed that compliance of Hon'ble Commission order dated 17.7.2023 must be ensured in letter in spirit and further ensure to submit copy of the same to this office, failing which, appropriate actions shall be taken.

1. The respondents have not made the compliance of order dated 1.6.2023 and even are not ready to argue the matter. They have submitted memo no. 26/62-2021 CIV (1) dated 14.07.2023 which is taken on record. As per the aforesaid memo, the necessary instructions have been issued to the concerned colleges and the legal opinion has been obtained from the O/o Advocate General, Haryana. The roster registers are being prepared by the concerned colleges but the issue of their verification has come up which requires to be taken care of.

2. Keeping in view the contents of the aforesaid memo and after hearing the representatives for the respondents, I am of the considered view that the specially constituted committee under the Chairmanship of Additional Director, Department of Social Justice,

Empowerment, Welfare of Scheduled Castes & Backward Classes and Antyodaya (SEWA) has to verify the roster registers of recruitment as well as of the promotion of divyang employees of All Govt./ Govt. Aided Institutions, including aided colleges in view of Govt. of Haryana instructions no. 1128-SW (4)-2023 dated 25.01.2023 hence the respondents shall ensure that the roster registers are put up before the aforesaid committee not later than 3 weeks and the necessary orders shall be issued within a period of 2 weeks thereafter with regard to the deem date promotions of divyang employees of all cadres and all groups in accordance with Govt. of Haryana instructions no. 22/59/2020-1 HR-III dated 11.07.2023 as well as the recruitment in accordance with Govt. of Haryana instructions dated 15.11.2021.

3. In view of above, the case is now adjourned to **29.08.2023** for final argument. It is made clear that no further adjournment shall be granted.
