**CONDITIONS:-**

1. The senior employee will be entitled to the benefit of *deemed promotion* w.e.f. the date on which his junior employee got promoted subject to the condition that he was otherwise eligible and fit for promotion on such date. Such retired senior employee shall be entitled to notional benefits only.
2. The aforementioned *deemed promotion* of the retired employee will be effective from the date mentioned against their respective names. In case anyone of them finds any discrepancy in this date, he/she shall submit a representation to the Directorate of Higher Education alongwith relevant facts, duly supported by documentary evidence within 15 days of the issuance of orders of *deemed promotion*, for further necessary action in the matter at the end of the Department.

3. The officer concerned must have been in Government service at the time when his/her junior in seniority was promoted.
4. The fixation of pay of the aforementioned retired employees shall be effected only if he/she is found eligible for the same upon verification of facts from his/her service book and all relevant official record of the employee. The retired employee who are being given deemed promotion shall be entitled to notional benefit only after his/her deemed promotion & he/she shall not be entitled for any arrears on the ground of these *deemed promotion*.


