

Sir/Madam,

I am directed to invite your kind attention to the Hon'ble High Court order dated 23.05.2019 & Government instruction of even number, dated 09.05.2019 vide which all the Departments/Boards/Corporations were directed that any candidates who obtained Sports Gradation Certificate issued after 19.01.2019 will be allowed to join by concerned Departments/Boards/Corporations.


2. The para 7 of Sports Policy Notification No. 4/40/2017-4SYA, dated 25.05.2018 issued by Sports & Youth Affairs Department, provides that an applicant is not entitled to any benefit, including appointment, under the Sports quota, unless supported by Sports Gradation Certificate of appropriate Grade in the format at Schedule-I of the said Notification.

3. The closing date for submission of online application for Group D posts was 18.09.2018 (by 11.59 PM). Therefore, as per Notification No. 4/40/2017-4SYA, dated 25.05.2018, the candidates should have acquired their Sports Gradation Certificates from Sports Department before last date of submitting application. But due to lack of awareness, some candidates could not acquire the said Gradation Certificates under the above new policy.

3. The matter has been re-considered by the State Government. Accordingly, it is directed that a last opportunity may be given to candidates who have not submitted Sports Gradation Certificate as per Notification dated 25.05.2018 issued by Sports & Youth Affairs Department. They may be directed to submit the same within one month positively i.e. latest by 31<sup>st</sup> August, 2019. If they fail to submit the requisite Sports Gradation Certificate by 31<sup>st</sup> August, 2019, the concerned authorities may proceed to withdraw the offer of appointments or terminate the services in respect of such candidates.


4. These instructions may be complied with in letter and spirit.


