

Please refer to an advisory issued vide my D.O. No. 3208 dated 27.10.2017 on the subject matter.

As informed by Department of Information Technology, Electronics & Communication Haryana (DITECH), the departments are not coming forward to get the In-Building Solution (IBS) installed in their respective Government buildings. As on date, only 5 Government buildings have been provisioned with this IBS. It has also been brought into my notice that Education Department and Haryana Police have also consented to get this system installed in the 22 and 16 Government buildings respectively. However, other departments are not coming forward to get this solution installed in their respective Government buildings.

As, this facility is free of cost and is to obtain good coverage and capacity to the mobile network inside the buildings, where the signal is significantly attenuated due to multiple walls, it is again advised to issue necessary directions to your respective departments to consider installation of IBS in Govt. buildings under their control and list of such buildings may be shared with DITECH for further necessary action.
