1. Introduction

1.1. Introduction & issuer

Despite the fact that India is one of the fastest growing economies in the world and with a huge productive and young population base, the country still lags behind many of her competitors like Israel, China. And, one of the most important reasons behind this situation is unaware and unskilled workforce, particularly youth. Despite significant progress and achievements in the education arena from public and private sector initiatives, the sector is plagued with several challenges and unable to generate the Entrepreneurship opportunities for our youth.

Haryana has gradually evolved as knowledge based economy due to the abundance of capable and qualified human capital. It has immense opportunity to establish its distinctive footing not only in the country but in the world. Empowering the students and making them educated and self-reliant has always been one of the prime concerns and focus of the Department of Higher Education. Department understands that Entrepreneurship plays a very important role in the economic development of the state and this objective can only be achieved by providing the Entrepreneurial Education to the youth, who wants to build their own enterprises and become job creators of the nation.

In order to promote the Self Employment/Entrepreneurship/Employment, Department of Higher Education would like to float an Expression of Interest to select a Private industry partner to educate the unemployed youth of Haryana on the Freelancing platform like upworks.com, Guru.com, Odesk.com and generate the freelancing/Self Employment opportunities in 31 colleges of excellence of Higher education. In the Pilot phase, Project will be delivered in 5 Colleges and will be replicated to other colleges based on the Selected partner performance. Through this program, Government will not only enhance the entrepreneurship but also increase the inflow of foreign currency, as the income from most of the freelancing portals comes in Foreign Currency.

Department of Higher Education, Haryana invites the eligible bidders to submit their Proposal to promote entrepreneurship and to provide Freelancing/Self-Employment/Employment opportunities to the youth of Haryana in 31 Colleges of excellence of Department of Higher

Education Haryana for 3 years in accordance with the conditions and manner prescribed in

this Expression of Interest document.

1.2. Purpose

Bidders are advised to study this RFP document carefully before submitting their proposals

in response to the RFP Notice. Submission of proposal in response to this notice shall be

deemed to have been done after carefully studying and examination of this document with full

understanding of its terms, conditions and implications.

2. (ELIGIBILITY CRITERIA)

2.1 Pre-Qualification Criteria

As part of eligibility criteria of RFP, only those bidders who meet the following Eligibility criteria are eligible to participate in the next round of bidding (RFP). Bidders failing to meet these criteria or not submitting requisite supporting documents / documentary evidence for supporting prequalification criteria are liable to be rejected summarily and will not be invited for next round.

Consortium of maximum two organization is allowed. However, lead bidder shall be solely responsible for the delivery and implementation of this project. Bidder must submit the consortium agreement with clear roles and responsibilities of each partner.

To be eligible for evaluation of its RFP, the sole bidder (in case of single business entity) or any bidder (in case of Consortium) shall fulfill the following Minimum Eligibility Criteria:

- The bidder should be a registered as private company incorporated in India under the (Indian) Companies Act 1956/2013 or Limited Liability Partnership (LLP) incorporated under Limited Liability Partnership Act 2008
- ii The Bidder/s (any one) must have minimum average annual turnover of Rs. 5 crores per annum in last 3 financial years and Rs. 1 Cr. per annum through export income in last 3 financial years. (as per Annexure- A)
- iii The bidder (any one) must have trained atleast 500 candidates on High end technical/ freelancing skills (as mentioned in this RFP) in last 3 years (as per Annexure-B)
- iv Bidder (any one) preferably have its office in Haryana or will acquire one office, if selected for this assignment
- v The bidder (any one) should have atleast 30 faculty/experts of Technical/Freelancing and Soft Skills on its payroll. (as per Annexure- C)
- vi Bidder (any one) should have done at least one project (with training of at least 1000

students) as training provider in IT/ITES Sector with Central/State Government in the last 3 years (as per Annexure- D)

vii The Bidder (both in case of Consortium) should not have been blacklisted by State/Central Government in the last 3 years. (as per Annexure- E)

NOTE: All the bidders who fulfill the above Pre-Eligibility criteria will be invited for Technical Presentation and those who qualify in Technical evaluation will be allowed to participate in financial bid.

3. INFORMATION AND INSTRUCTIONS TO THE BIDDERS

3.1 Important Information

3.2 Process and Stages for Selection

- a. There will be a two-stage selection process (collectively the "Selection Process") in evaluating the Proposals.
- b. In the first stage, a preliminary scrutiny based on the 'Eligibility Criteria' (Section 2.1) shall be done. All bidders who successfully meet the 'Eligibility Criteria' shall be deemed qualified to move

to the 'Technical Evaluation' round.

c. In the second stage 'Technical Evaluation' mentioned in and technical evaluation criteria will be carried out as specified in Section 5

d. Based on the technical evaluation, a list of short-listed Agencies shall be prepared which clears the technical round. In the final stage, financial evaluation of such short-listed Agencies will be carried out. The Agency shall be selected on the basis of L1.

3.3 Other Information:

- a. Material deficiencies in providing the information requested may result in rejection of the proposal. Department's decision in this regard shall be final and binding.
- b. The cost to be incurred by the prospective bidders to prepare the proposals and for negotiating the contract, including any visits to the department.
- c. Information relating to evaluation of proposals and recommendations concerning award shall neither be disclosed to the bidders nor to other persons not officially concerned with the process.
- d. During evaluation of the proposals, department may, at its discretion, ask the bidders for clarifications on their proposal. The bidders are required to respond within the time frame prescribed by department.

3.4 Preparation of Proposal:

The instructions for submitting the RFP are mentioned below:

- 3.4.1 RFP and all associated correspondence shall be written in English and shall conform to prescribed formats. Any interlineations, erasures or over writings shall be valid only if they are initialed by the authorized person signing the RFP.
- 3.4.2 The bids shall be submitted in a single sealed envelope and superscripted "Prequalification Proposal: "promoting entrepreneurship and to Provide Freelancing /Self-Employment /Employment opportunities to the youth of Haryana in 31 Colleges of excellence of Department of Higher Education Haryana for 3 years". This envelope should contain hard copy of "Prequalification Proposal" along with all relevant documents.

- 3.4.3 Bids shall consist of the required supporting proofs and documents as defined in the prequalification section.
- 3.4.4 It should be ensured that various formats mentioned in this RFP should be strictly adhered to and no changes in the format should be done.
- 3.4.5 Envelope should indicate clearly the name, address, telephone number, Email ID and fax number of the bidder.
- 3.4.6 RFP document submitted by the bidder should be concise and contain only relevant information as required under this RFP.
- 3.4.7 The bidder would be responsible for all of its expenses, costs and risks incurred towards preparation of the RFP document.

4. SCOPE OF WORK

4.1 Objective of RFP

- Overall objective of this RFP is to engage an organization with proven capabilities to triain
 the youth of Haryana on new innovative courses and generate Freelancing/selfEmployment/Employment opportunities for the candidates in 31 colleges of excellence of
 department of higher education for a period of 3 years.
- In the Pilot phase, Bidder will be selected to implement this project in only 5 colleges which can be further implemented to other colleges based on the performance of the bidder.
- This section describes the broad scope of work that shall be carried out by the bidder who is selected in the final stage to deliver and manage the required solution.
- The scope of work mentioned in this section is indicative only and could be modified as per actual requirement during delivery phase.
- The agreement will be initially valid for 3 years which can be extended to another 2 years based on performance.

4.2 Scope of Work post finalization and selection

Department of Higher Education have 31 colleges of excellence having good infrastructure. Department would like to select a Private industry partner who can utilize this infrastructure and train the candidates from inside or outside the college campus (as per the Target youth criteria mentioned in this document) on the new innovative courses and deliver the following services in these colleges for a period of 3 years, which can be extended to another 2 years based on the performance.

This program will cater to educated unemployed graduates and aims to reduce the rate of unemployment by encouraging self-employment through internet-based freelance work opportunities. Project aims to provide training to budding freelancers to help improve their skill set and assist them in earning a sustainable income and achieve upward economic mobility.

4.2.1 The selected vendor performs the below mentioned activities and generate Freelanding/Self Employment/Employment opportunities for the candidates who successfully complete the defined curriculum under this project.

- i To arrange the innovative high end training program for the candidates by appointing highly Skilled trainers from Industry.
- ii Any Existing Students of College/Unemployed Graduates/Post Graduate youth/College Dropouts from Haryana between the age group of 18-30 can be eligible under this program
- **iii** To mobilize the candidates from inside or outside the campus, counsel them on the earning opportunities from freelancing portals and create batches.
- iv To provide extensive training on Communication Skills, Bidding Skills on Freelancing portals and Technical Skills.
- v Generate employment and sales opportunities in leading portals and other mediums thereby providing the opportunity to earn money in foreign Currency.
- **vi** Department will ensure the attendance of regular candidates (from campus) enrolled in this program by making their regular classes schedule flexible.
- **vii** Performance will be evaluated based on the work awarded/money earned by the candidates from the freelancing portal or from their own start-ups.
- viii This program should be open for all the students in and around city (Age less than 30 years) on the approval from department to attend training and get self-employment opportunities and space to work based on availability.
- ix To generate revenue from the startups/freelancers established after the completion of training which should be equal to or more than 50% of the amount claimed by the bidder from the Department.

4.2.2 Core Training:

4-6 months training will be provided to the shortlisted candidates on the below modules having high demand on Freelancing portals.

- Communication Skills
- Bidding Skills on Freelancing portals
- Technical Skills (Training on emerging technologies like Internet of Things, Artificial Intelligence, Blockchain, Web and Mobile Applications or others which are in demand on freelancing portals.)

4.2.3 Target Youth to be covered under the scheme:

- Any Existing Students of College/Unemployed Graduates/Post Graduate youth/College Dropouts
- Domicile of Haryana

Between the age of 18-30 Years.

4.2.4 Handholding

After successful training on the above, Bidder will assist the candidate as per the below expectation

- Handholding of candidates in creating their startups or assisting them in earning from freelancing opportunities.
- Entrepreneurship Kits to be designed for each candidates including but not limited to Visiting Cards, Business name, Freelancing Bidder Profile, Bidding Template or marketing brochures.
- Bidder can create startups with interested candidates and help them in earning from freelancing portals.

4.2.5 Reporting:

Department will monitor the performance on the following parameters.

- Number of candidates enrolled and successfully completed the Training Program. Bidder will submit the quarterly report of all the batches enrolled under this program.
- Number of candidates provided freelanding/Self-Employment/Employment opportunities after completion of training.
- Number of Startups Created from the candidates along with Startup detail and their earning potential.
- Submit the Earning Proof of candidates in the form of Bank Statement/Work Orders/Other relevant Proof, confirming their engagement in Freelancing/Self Employment/Employment opportunities.
- Bidder should ensure that they will arrange the income opportunities for the candidates enrolled under this program and it should be minimum 50% of the amount claimed by the bidder from the Department.

4.3 Expected Outcome of this Scheme:

After the successful completion of this training program, below is the expected outcome:

- Students trained under this program should be able to start their earnings from leading portals or other medium.
- Many new Startups will be created from the successful trained candidates.
- Increase in foreign exchange as the income generated from freelancing portals is in USD.
- Department can earn revenue by providing paid training to outside candidates.

 Once established, Department may charge per seat charges from the startup earning revenues.

4.4 Deliverables from Department of Higher Education, Haryana:

- Provide minimum 1 Theory Room with Projector and seating capacity of 30 candidates.
- Provide minimum 1 Computer labs with 30 computers (with i7 configuration)
- Provide free access to the assigned space as per the area defined.
- All assets will remain under the ownership of Department.
- All legal and statutory clearances in concern with the property including property tax,
 Municipal Corporation Charges etc. will be paid by the Department.
- Power backup, Electricity and water expenses will be paid by the College.

4.5 Payment Milestones:

The Selected firm shall submit monthly invoices along with the status reports to the department and payment shall be released on monthly basis.

5. Evaluation of Technical Proposal

- 5.1 The Technical Proposals would be evaluated only for those Bidders, who qualify the Prequalification evaluation.
- 5.2 Technical proposal of all the Applicants will be evaluated based on Agency experience and financial capability.
- 5.3 The agencies will need to score a minimum of 70 marks to qualify the technical evaluation.
- 5.4 Technical proposals of all the Applicants will be evaluated based on appropriate marking system. The categories for marking and their respective weight-age are as detailed as follows:
