Subject: Scheme for Educational and Excursion Tour for Boy Students of Govt. Colleges for the year 2018-19.

Sanction of Governor of Haryana is hereby accorded to the issuance of administrative approval for the inclusion of the scheme cited as subject in the schedule of new expenditure for the year 2018-19 and incurring of an expenditure on Non-recurring basis at a cost of **Rs. 34,65,375/-** (Rs. Thirty Four Lac Sixty Five Thousand Three Hundred Seventy Five only) out of Rs. 50.00 Lac (Rs. Fifty Lac only) under **Educational and Excursion Tour for Boy Students for the year 2018-19** as per details given in the scheme subject to the following conditions:-

- i. The expenditure will remain within the sanctioned budget provision and will be incurred as per prescribed norms/rules with the approval of the competent authority.
 - ii. The Scheme will be included in the Annual Plan and be ensured that the plan ceiling is not increased under any circumstances even if the cut is imposed at a later stage.
 - iii. This amount will be drawn by concerned Principal of the Government College through the concerned treasury. The amount will be utilized as per directions of Director, Higher Education, Haryana, Panchkula. The allocated amount will be sent through online to the Colleges.
 - iv. Instructions issued by F.D. vide its U.O. No 5/6/2005 B&C dated 11.06.2010 be complied with strictly.
 - v. Revised sanction will be issued in case provision of the scheme is modified at any stage

3. The amount will be the drawn by **the Principal and will be disbursed and utilized for various activities mentioned in the scheme.**
4. The expenditure shall be incurred in the following phases- **100% in a year.**
5. Date by which the entire expenditure shall be completed by **28.02.2019.**
6. Date by which the accounts should be rendered/compliance information given to the headquarter **28.02.2019.**
7. Undertaking should be taken from the parents of the students.
8. Any other fee will not be charged from the students.
9. **Procedure to be followed** –The amount will be distributed by the Director Higher Education, Haryana, Panchkula depending upon the number of students and will be drawn by the Principal of the concerned Govt. College through their treasury. Record will be maintained by the DDOs concerned. Deputy Director, office of Director Higher Education, Haryana, Panchkula will monitor the progress for effective implementation of the scheme.
10. The College where the DD powers are allotted to Principal of a neighbouring college, that incharge Principal will draw the amount.
11. The Officer is responsible for implementing the scheme and the DDOs shall strictly follow the guidelines given below:-

Short trips/Fun trips & Educational Excursion Tours

These trips shall be organized by In-charges of various subject committees constituted in the colleges in the stream of Arts, Commerce, Science as well as Job-Oriented Courses. The trips may be of the duration of one day to three or four days. The students will visit the places/ sights of historical, geographical, scientific and commercial importance.
