

Verification of character and antecedents of selected candidates before their first appointment to Government service - relaxation thereof.

Sir,

I am directed to invite reference to Haryana Government letter No. 7473-7S/14433, dated 08.06.1976 on the subject cited above

2. The Departments frequently seek relaxation in the Govt. Instructions regarding prior verification of character and antecedents of selected candidates from GAD. The matter has been examined by the Government at length and it has been decided to grant partial relaxation in respect of the provisions of this letter and all other instructions issued by the Govt. from time to time on this subject, that all the candidates recommended by the HSSC till 30.09.2018 in respect of appointment to any post, may be appointed on provisional basis, without prior verification of their character and antecedents.

3. Their character and antecedents should however, be got verified within a period of two months after their provisional appointment and this relaxation does not confer any right to a candidate to remain in job, if subsequently any time adverse is reported against him/her at a later stage.

4. This relaxation in the instructions would lapse automatically after 30.09.2018.
