



Sir/Madam,

I am directed to invite your attention towards Government letter 62/30/95-6GS1, dated 4.1.1996 on the subject noted above vide which the instructions were issued that in such cases where the petitions are filed against the concerned Administrative Secretaries and the Chief Secretary to Government, Haryana, where the issues involved in the will petitions are not at all require to be decided at their level and further in such a situation the Chief Secretary to Government Haryana continues to be respondent, though his name should have been deleted from the list of respondents on the ground of misjoinder of parties. Therefore, it was decided that in such cases the name of Chief Secretary should be got deleted from the list of respondents on the grounds of misjoinder of parties at the first instance.

It has been observed by the Government that it has become a healthy trend that despite the above said instructions the cases are being filed against the State wherein Chief Secretary is being implemented as respondent, but no relief has been claimed by the petitioner(s) from the Chief Secretary


