The Minutes of 2nd State Level Committee Meeting, Haryana was held under the Chairmanship of Sh. Sanjeev Kaushal, Chief Secretary to Government Haryana on 22.07.2022 at 03:00 P.M. in Main Committee Room, 4th Floor, Haryana Civil Secretariat (Main Building), Chandigarh.

Sh. Gyanenshwar Singh, IPS Deputy Director General (Northern Region) Narcotics Control Bureau New Delhi stated that NCB is the National Nodal Agency for drug control in India. There are other agencies like DRI, Police, CBN and border guarding forces which are also working on the enforcement side. Recently, there has been focus on curbing the demand side (drugs) for which various departments including Ministry of Health, Ministry of Social Welfare, Deptt. Of Education, etc., were included in the NCORD mechanism and these departments are doing their best to create awareness among the masses about the perils of drug abuse and addiction. Sh. Gyaneshwar Singh, DDG (NR) further stated that State Level Meeting of NCORD for Haryana was held on 04th February 2021 which, however, as per MHA Order No.I-12023/02/2017-NCB-II(Vol.I) dated 25.03.2022, should be held on quarterly basis. This was followed by a presentation by DDG (NR), NCB on the agenda points and following decisions were taken in the meeting:-Agenda 1: ANTF: It is mentioned that State of Haryana has already constituted a dedicated and specialised unit- Haryana State Narcotics Control Bureau (HSNCB) vide notification No. 5/2/2020-2H(C) dated 25th August, 2020. However the nomenclature of HSNCB can be changed to Anti Narcotics Task Force (ANTF) after obtaining approval of competent authority. As per the directions of Union Home Minister such ANTF should be notified as NCORD Secretariat of the State in future. It was decided that the proposal renaming HSNCB and its notification as NCORD Secretariat shall be examined.

(Action: Home Department Haryana/ADGP, HSNCB)

Agenda 2: Coordination: It was conveyed that the Union Home Minister has instructed that state and district level NCORD meetings should be conducted regularly. It was also mentioned that these meetings should be coordinated by HSNCB/State ANTF and also the minutes of these meetings be uploaded on NCORD Portal. The DDG (NR) informed that district level NCORD meeting should be conducted by DMs on monthly basis and the details of such meetings be shared with NCB. The importance of coordination was highlighted as the drug offences and consumption can only be resolved with better coordination amongst all stakeholders at the cutting edge 'district level'. ADGP, HSNCB informed that district level meetings are now being regularly conducted. Zonal Director, NCB, Chandigarh informed that neither intimation of such meetings was being provided to NCB and nor member from NCB is being invited. It was decided

that henceforth a member from NCB be invited in all district level NCORD meetings and the minutes of meetings be provided to NCB.

(Action: HSNCB/All agencies) Agenda 3: Capacity Building: The DDG (NR) NCB emphasized that there is a need to enhance the skills/capacity of the officers engaged in Drug Law Enforcement Activity. To improve the conviction rate, it is necessary that training of Public Prosecutors may also be conducted. The state may project its requirement in field of drug supply/demand and harm reduction to NCB Chandigarh upon which training can be organised by NCB. It was also informed that training modules have been designed by NCB in coordination with BPR&D & NACIN. The modules have been approved by MHA and circulated to all stakeholders. NCB can also organize a customised workshop covering different subjects as proposed by State. It was also informed that a workshop for officers of Haryana was organised on 19th April, 2022 and 05th July, 2022 at Haryana Police Academy, Madhuban which was attended by SHOs, DSPs, Investigating Officers and constable Jawans. It was also requested that a nodal officer from Haryana Police may also be nominated to coordinate with NCB nodal officer regarding their training requirements.

(Action: DGP, Haryana/NCB)

Agenda 4: Awareness Drive: The DDG (NR) emphasised that Haryana State Action Plan for drug demand and harm reduction may be shared with NCB. Awareness programs such as Marathons, Cycling Event, Rally against drug abuse may be conducted in the state of Haryana. The Anti drug message 'Say no to drugs' may be spread as part of the mass awareness drive in collaboration with Haryana Police. It was informed that regular awareness activities are being carried out all across the state by various stake holders and under the dedicated 'Dhakkad Programme' awareness activities are being carried out at level of educational institutions across the state.

Agenda 5 :Anti Drug E-Pledge : The forum was briefed about NCB's awareness drive regarding taking E Pledge. It was highlighted that the population of Haryana is 2.7 Crores and E-Pledge taken was only by 80,000. It was decided that all government servants should take E-Pledge and the State Education Department should ensure that all students and teachers should take anti drug E-Pledge and instructions should be issued to various schools and colleges for taking the Anti Drug e Pledge by the Education Department. It was further informed by ADGP-HSNCB that E-pledges have also been taken by general public and students of various educational institutions in Haryana through HSNCB websitehttps://ncbharyana.in/. As on 25th July 2022, total 107911 E-pledges have been taken and certificates downloaded:

(Action: Deptt. Of Education, Haryana)

Agenda 6: Installation of Warning Signages in Restaurants, Hotels, Bars, Cafes and Pubs, etc. : It was requested that the display of the Anti Drug Warning Signages in Restaurants, Hotels, Bars, Cafes and Pubs should be made mandatory. The circular of Delhi Excise Deptt. in this regard was cited as example. It was decided that Excise Department to issue a circular in this regard inter alia to instruct the Restaurants, Hotels, Bars and Pubs to display the appropriate Warning Signage at the prominent place on its premises. It was suggested that possibility of the mandatory display of Anti Drug Signage could become part of their excise policy in due Course.

(Action: Excise Department, Haryana)

Agenda 7: Assistance to States: It was informed that during the year 2020-21 an amount of Rs.51,57,387/- was sanctioned to the State of Haryana under Assistance to States Scheme. The State was requested to submit Utilisation Certificate of the amount. Various areas under which proposal for assistance to states can be forwarded were also discussed during the meeting.

(Action: DGP, Haryana/NCB)

Agenda 8: National Fund for Control of Drug Abuse (NFCDA): The DDG NR highlighted (i). that Funds under NFCDA are also provided for combating illicit trafficking and abuse of narcotic drugs, psychotropic substances and/or controlled substances. The objective is also to reduce the demand side by conducting awareness programmes in cooperation with Ministry of Social Justice and Ministry of Health. The proposal for the same can be forwarded to JS (Rev), Ministry of Finance and NCB shall help in coordinating on behalf of State of Haryana.

(Action: All Concerned Deptt.)

Agenda 9: Upgradation of FSLs: The DDG NR stated that state may upgrade the FSLs as (ii). per identified requirements. It was stated that recently state of Rajasthan has been sanctioned Rs.1.42Crores for the upgradation of FSL under NFCDA. State of Haryana may consider submitting proposal for funds for upgradation of FSLs under NFCDA.

(Action : Police Deptt. Haryana/FSL Haryana)

Agenda 10: Establishment of De-addiction Centres: The DDG (NR) stated that (iii). adequate Govt. De-addiction centres as per requirements may be established in the State of Haryana. Health & Family Welfare Department should be made the nodal agency to propose a project / action plan and funds may be sought under NFCDA in this regard.

(Action: Health & Family Welfare Department)

Other agenda Points by Haryana State Narcotics Control Bureau: It was appraised by (iv) ADGP/HSNCB that, for real-time monitoring of drug precursors used by manufacturers, downstream supply chain and retail sales of pharmaceutical drugs potentially used as substance of abuse, repeated use of prescriptions, etc., an android mobile App. "Sathi" has been jointly

developed by HSNCB and Haryana State Drug Controller and being deployed in the state of Haryana. It may also be got deployed at pan India level. Chief Secretary to Government Haryana opined that the proposal for exploring the possibility of its deployment at pan India level may be got examined through the O/o Drug Controller General of India.

(Action: FDA-SDC Haryana & HSNCB)

3. It was also desired by Chief Secretary to Government Haryana that the use of e-way bill portal be examined by HSNCB to check the flow of drugs from Himachal Pradesh.

The meeting concluded with thanks to all present.
