





**Subject:- No VIP Symbols on vehicles.**


Sir/Madam,

I am directed to refer to subject cited above and to inform you that Hon'ble High Court of Punjab and Haryana had passed an order on 24.01.2020, in CWP-PIL No. 78 of 2019 in Case Titled as Court on its own motion Versus the Chandigarh Administration and others. The order is reproduced below :-

"During the course of hearing, it was brought to the notice of the Court by the learned amicus curiae that on Government vehicles/private vehicles, designation/descriptions of offices/unauthorized emblems are displayed. Words like Court, Army, Police, Press etc. are written on private vehicles, which is not permissible under the law. Accordingly, the display of designation/description of offices/unauthorized use of emblems on Government/private vehicles is banned forthwith. Writing of words, like Court, Army, Airport/Navy Police, Press or any designation, like Chairman, vice Chairman, on private vehicles and Government vehicles is prohibited forthwith. This direction be implement by Chandigarh Administration within 72 hours."

- 2 All concerned are directed to comply with the High Court order in letter & Spirit.
