

**Subject:- CWP No. 19737 of 2018 Mahender Pal Vs State of Haryana and others.**

Sir/Madam,

I am directed to address you on the subject noted above and to say that the powers of collector are conferred upon Assistant Commissioner and Extra Assistant Commissioners under various acts to perform the duties and functions of Collector to hear appeals from the orders and decrees of Assistant Collector of the 1<sup>st</sup> and 2<sup>nd</sup> Grades under the said acts. Few instances have come to the notice that officers who have been entrusted with these powers to adjudicate as a quasi-judicial authority have passed orders which are not legally sound leading to unnecessary litigation and harassment to the litigants. The Government has viewed this seriously and it has been decided that officers having judicial & quasi-judicial powers take special care to be aware of the nuances of legal matters and take up court matters also with equal sincerity as their administrative work.

2. These instructions be brought to the notice of all concerned for their information/compliance.
