Subject **Regarding engagement under Outsourcing policy part-II.**

Kindly refer to the subject cited above.

It is intimated that Haryana Govt Human Resources Department (Human Resources-III Branch) has been re considered the instructions issued Vide No. 16/07/2015 4HR-III dated 09.09.2022 and following descision have been taken:-

- (i) The employees engaged under Outsourcing Policy part-II and working on group C and D posts may be offered the option of being ported to HKRN. A time of 3 months is given to exercise the option.
- (ii) The extension in the engagement of employees appointed under Outsourcing Policy part-II is given for a period of one year for those who do not accept the option of being ported to HRKN or who are working on Group A or Group B posts or under any law enacted by the State.

In this regard Government has been clarified that services of employees mentioned at (ii) above appointed also under Outsourcing Policy part-II will be the first to be terminated in case regular appointment is made on such posts.

Therefore you are hereby requested to taken action according to instructions issued Vide no 16/07/2015 dated 30.12.2022 by the Haryana Government. (Copy enclosed)
