Subject: Regarding engagement under Outsourcing Policy Part-II.

Sir/Madam,

I am directed to invite your kind attention to Government instructions of even number dated 09th September, 2022 vide which Outsourcing Policy Part-II was revived for those employees who had been appointed under Outsourcing Policy Part-II against sanction posts and were in service as on 28.09.2021 and they were allowed to continue till regular appointments are made against these posts or till 31.12.2022, whichever is earlier.

- 2. Now, the matter has been re-considered and following decisions have been taken:-
 - (i) The employees engaged under Outsourcing Policy, Part-II and working on Group C and Group D posts may be offered the option of being ported to HKRN. A time of 3 months is given to exercise the option.
 - (ii) The extension in the engagement of employees appointed under Outsourcing Policy, Part-II is given for a period of one year for those who do not accept the option of being ported to HKRN or who are working on Group A or Group B posts or under any law enacted by the State.
- 3. It is further clarified that services of employees mentioned at 2 (ii) above, appointed under Outsourcing Policy, Part-II will be the first to be terminated in case regular appointment is made on such posts.
- 4. These instructions may please be brought to the notice of all concerned for strict compliance.
