

The 27th November, 2018

No. S.O. 86/C.A. 2/1974/S. 7/2018.— In exercise of the powers conferred by sub-section (3) of section 7 of the Code of Criminal Procedure, 1973 (Act 2 of 1974) and in supersession of Haryana Government, Administration of Justice Department, Notification No. 21/243/2016-2-JJ-II, dated the 30th November, 2016, the Governor of Haryana after consultation with the Hon'ble High Court of Punjab and Haryana, hereby alters the limits of sub-division Narwana and sub-division Jind by excluding therefrom the area comprising of Uchana tahsil and Alewa tahsil by creating a new sub-division for the area of Uchana tahsil and Alewa tahsil with headquarter at Uchana.
