

- 1) The request for taking house on rent should be put on reputed websites like 99 acres.com.rent alhouses.com.realtor.com'
- 2) The offers available on the websites should be examined and negotiated with at least three best offers available and the Committee, in its assessment should recommend the best offer alongwith comperative statement and the rent assessed by department of PWD(B&R) as per their guidelines.

Keeping in view the position explained above, you are, therefore, requested that use/ follow up guidelines directions mentioned above on 1) & 2) in future when initiated the rent matter to the Government.
