**Aims and Objectives**

The process of rehabilitation of alcohol and drug dependents is an inter-disciplinary process covering various aspect namely prevention, early detection, intervention, education, vocational training, rehabilitation and social integration etc.

This problem is considered a psycho-social-medical problem, society based approach for this problem is considered as the best approach for treatment and rehabilitation of the addicts. In order to recognize the efforts and to increase excellence in the field of substance abuse the scheme is formulated for comparing the state awards for outstanding services in the field of prevention of alcoholism and substance abuse.

**Objectives and Scope**

The Department of Social Justice and Empowerment is the Nodal Department for Drug Demand Reduction. It endeavours to monitor to all aspects of Drug abuse prevention which include assessment of the problem, preventive action, treatment and rehabilitation of addict, dissemination of information and public education.

To recognize the efforts and encourage excellence in the prevention of alcoholism and substance abuse and rehabilitation of its victim, awards shall be presented every year for the most effective or outstanding services as individual as well as institutions in the prevention of abuse of:-

**Selection Procedure for Nomination**

A. Applicant shall submit his / her request along with bio-data and their photo affixed to the District Social Welfare officer of the District Concerned and the District Social Welfare Officer will send his / her application along with his/ her inspection report and recommendation through the concern Deputy Commissioner.

B. Selection for State Awards shall be made by the Departmental Committee consisting of Director, Social Justice and empowerment and all Deputy Directors of the Department. The departmental committee shall submit its recommendations to the State Selection committee for making final selection.
