

## Subject: Appointment of Peon (Group-D).

On the recommendation of the Haryana Staff Selection Commission vide letter No. HSSC/Confd/Recomm/2024/411 dated 17.07.2024 you are hereby appointed as PEON in the Schedule-I, Pay Matrix Level-DL in Haryana Civil Services (Revised Pay) Rules, 2016 on purely temporary/ provisional basis. You will submit your joining report to the undersigned on the terms and conditions given below:

## TERMS & CONDITIONS:-

- 1. You are appointed purely on temporary/ provisional basis.
- 2. This appointment is against temporary post and you confirmation against substantive post shall be considered on the basis of your seniority and record of service as and when such post will available.
- 3. This is subject to verification and validity of gradation of certificates of other candidates to be received from Sports Department. If any candidate higher in merit is found to have a valid Gradation Certificate by the Sports department, the candidate lower in merit even if he/she is already joined, shall be terminated without any intimation.
- 4. If at any stage you desire to resign, you will be required to give one month advance notice or deposit forfeit in lieu thereof salary including allowances for one month or for the period by which the notice falls short of one month. The Directorate will give such a notice to you also in case it is proposed to terminate your services for the reason other than that mentioned in Clause-Labove.
- 5. You will remain on probation for a period of two years from the date of joining in the Department which may further be extended for a period of one year. In case your work and conduct is not found satisfactory during the period of

- probation, your services are liable to be terminated forthwith without assigning any reason.

- 7. You will be required to take the prescribed oath of allegiance to the Constitution of India.
- 8. In case you are married, you will have to furnish a declaration to the effect that you are not having more than one livings spouse.
- 9. In case you are married, you have to furnished a declaration to the Head of the Department that you have not taken any dowry after marriage. The declaration should be signed by your wife, father and father-in-law, as per Chief Secretary to Govt. Haryana letter No. 18/1/2004-2GSI dated 21.02.2006.
- 10. You should submit the medical certificate of fitness from the concerned Chief Medical Officer after joining within seven days.
- 11. If you have not been vaccinated within the last twelve months, you should get yourself vaccinated before joining the duty.
