

## **Terms and Conidtions**

- 1. They are appointed purely on temporarily / provisional basis.
- 2. Their appointment is against temporary posts and their confirmation against substantive posts shall be considered on the basis of their seniority and record of service as and when such posts are available.
- 3. The selected candidates have not been medically examined and no special enquiry into their antecedents has been made. The document pertaining to their Essential Qualification, Age, Caste/Category, College/Universities etc. as claimed by the candidates in the application form may be got verified from the issuing authorities.
- 4. If at any stage they desire to resign from their post, they will be required to give one month's notice or forfeit in lieu thereof their salary including allowances for one month or for the period by which the notice falls short of one month. The Directorate will give such a notice to them also in case it is proposed to terminate their service for the reasons other than that mentioned in clause (1) above.
- 5. They will remain on probation for a period of two years from the date of joining in the department. The period of probation can be extended in accordance with the existing rules. For assessing their performance during the period of probation, their work and conduct will be taken into consideration.
- 6. It is also made clear here that character and antecedents of newly appointed candidates have not been verified by the department in terms of Government

instruction issued vide No. 52/18/2018-3GSIII dated 18<sup>th</sup> August, 2020 and issued from time to time by the State Government. In case, any adverse facts come to the notice of the State/ Department regarding your character and antecedents, their services are liable to be terminated without giving any notice.

- 7. They will be required to take the prescribed oath of allegiance to the Constitution of India.
- 8. In case they are married, they will produce the certificate that they are not having more than one living spouse.
- 9. In case they are married, they will have to furnish a declaration to the Head of department that they have not taken any dowry after marriage. The declaration should be signed by their wife, father and father in law, as per Chief Secretary, Haryana letter no. 18/1/2004-2GSI dated 21.02.2006.
- 10. If they are unmarried, they will have to take an oath of allegiance to the Constitution of India and affirm that they do not give or take or abet the giving or taking of dowry, or demand, directly or indirectly from the parents or guardians of the bride or bridegroom, as the case may be, any dowry, as per Chief Secretary, Haryana letter no. 18/1/2004-2GSI dated 21.02.2006.
- 11. This offer of appointment is further subject to your submission of medical fitness certificate from the concerned Chief Medical officer within 15 days from the date of appointment, failing which this appointment will stand cancelled.
- **12.** Their appointment is subject to final verification of their educational qualification and other eligibility conditions.
- 13. At any stage if the certificates produced by them are found to be bogus or defective, their service shall be terminated. Notwithstanding anything contained in this appointment letter, their appointment is subject to condition that if they are found unfit/unsuitable for appointment to Government Service on the basis of medical report or on the basis of character and antecedents' Verification or otherwise, their service shall be terminated forthwith without prejudice to any other terms and conditions.
- 14. They will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for pursuing higher studies.
- 15. They will be required to produce the original educational documents pertaining to their qualification, experience, age and caste/ category, as claimed by them in the application form & others before joining your duties.
- 16. No TA/DA or joining time will be allowed to them for joining this post.
- 17. Their services will be governed by Haryana Education Directorate (State Service Class-III)Rules 1974 as amended from time to time.
- 18. Their seniority will be fixed in accordance with the Departmental Rules.
- 19. They will be governed by NEW PENSION RULES as notified vide No. 1/1/2004-1Pension, dated 18.8.2008.
- 20. Their appointment is subject to matching of Biometric/Facial verification. Attendance within two weeks from the date of Joining.

If the above terms and conditions are acceptable to you, you should report for duty within 15 days of the receipt of appointment order alongwith relevant documents stated above, failing which appointment order will be cancelled.

Note:- The appointee would not be entitled to any claim/benefit because of anything essential regarding rules & regulations left to be quoted in this appointment order or any clerical mistake/error.
