any stake-holder or any person interested shall be at liberty to place the material before the Haryana Backward Class Commission in this regard;

the State Government, the Welfare of Scheduled Castes and III. Backward Classes Department and/or any other department as also any other stake-holder or interested person may submit data for or against the reservation before the Haryana Backward Class Commission by 30.11.2017;

- IV. the State Government shall make due and wide publication for submitting the data to the Haryana Backward Class Commission by the said date;
