

Minutes of the meeting held on 23.07.2024 under the Chairmanship of Sh. Anand Mohan Sharan, IAS, Additional Chief Secretary to Government, Environment, Forest and Wildlife Department, Chandigarh regarding preparation for State wide One Day Mass Plantation Drive under umbrella of 'Ek Ped Maa ke Naam' Campaign.

The above said meeting was held on 23.07.2024 at Haryana Niwas, Sector - 3, Chandigarh under the Chairmanship of Sh. Anand Mohan Sharan, IAS, Additional Chief Secretary to Government, Environment, Forest and Wildlife Department in the presence of Dr. Amit Aggarwal, IAS, APS, CM. The planning and preparation for State Level One Day Mass Plantation Drive under the umbrella of 'Ek Ped Maa ke Naam' Campaign to be undertaken on International Youth Day i.e. 12.08.2024 was reviewed in this meeting. The list of participants is placed at Annexure - I.

At the outset, Sh. Anand Mohan Sharan, IAS gave an overview about the scheme 'Ek Ped Maa Ke Naam'. He informed that the Ministry of Environment, Forest and Climate Change, Government of India has allotted a plantation target of 160 lac seedlings for the State of Haryana to be planted during the financial year 2024-25. It was further informed that out of this allotted target, 100 lac seedlings are to be planted till September, 2024 and balance is to be achieved till March, 2025. Further that the target of 37.44 lac has already been achieved till 22.07.2024.

Sh. Amit Aggarwal, IAS informed the participants that the Mass Plantation Drive will be undertaken collectively by various line departments on 12.08.2024 under the leadership of District Administration with active involvement of all District Level Officer, Volunteers, Social / Religious Organizations etc. After detailed deliberations, following decisions were taken:-

1. Principal Chief Conservator of Forest (HoFF) will write to all the Deputy Commissioners giving details of the programme. The Deputy Commissioners will also hold meeting with the District level Officers in this regard.
2. In the Plantation Drive, every District will achieve a plantation target of at least 2 lac seedlings. Accordingly, the Deputy Commissioners will assign the plantation targets to the District level Officers depending on the availability of land and capability of the concerned department. The entire Plantation

Drive will be steered by the Deputy Commissioner and the required technical support and seedlings will be provided by the Forest Department.

3. The Divisional Forest Officer will provide location of nurseries along with detail of available species and will ensure availability of saplings from the Departmental Nurseries free of cost. The responsibility of lifting and transporting of the seedlings from the nurseries will lie on the concerned Department depending upon their plantation targets. The saplings will be supplied after digging of pits. Further that the requisite number of plants will be made available at each plantation site every Department before the scheduled date of Mass Plantation Drive i.e. 12.08.2024.
4. The concerned Departments will ensure digging of pits of proper size in advance for the planting to be undertaken on 12.08.2024.
5. Every plantation site will be Geo-Tagged and will be uploaded on Meri Life Portal developed by MoEF & CC, Government of India (merilife.nic.in).
6. To further review the planning and progress related to this event, a meeting of all the Deputy Commissioners will be taken by the ACS to Govt., Environment, Forest and Wildlife Department, Government of Haryana on 25.07.2024.
7. The plantation targets under the campaign allotted to various line Departments in consultation with their representatives are as under:-
