2. Sub-section (2) of section 1 of Indira Gandhi University, Meerpur, Act, 2013 (hereinafter called the principal Act), shall be omitted. Amendment of section 1 of Haryana Act 29 of 2013
3. Notwithstanding notification under sub-section (2) of section 1 of the principal Act having not been issued, anything done or any action taken or purported to have been done or taken during the period commencing from the 26th November, 2013, under the provisions of the principal Act to the commencement of this amending Act, shall, for all purposes, be deemed to be, and to have always been done and taken in accordance with law and shall not be called in question before any court of law on this ground.
