State of Haryana and others alongwith bunch of writ petitions, subsequently upheld by Hon'ble Supreme Court of India and further, order dated 23.05.2022 passed by Hon'ble Punjab and Haryana High Court in CWP No. 4429 of 2020 titled as Virendra Singh Malhan and others Versus State of Haryana and others subject to fulfillment of the terms and conditions given below:-

CONDITIONS:-

- 1. He will be entitled to the benefit of *deemed promotion* w.e.f. the date on which his/her junior employee got promoted subject to the condition that he/she was otherwise eligible and fit for promotion on such date. He shall be entitled to notional benefits only.
- 2. His deemed promotion will be effective from the date mentioned above. In case she finds any discrepancy in this date, he shall submit a representation to the Directorate of Higher Education alongwith relevant facts, duly supported by documentary evidence within 15 days of the issuance of orders of deemed promotion, for further necessary action in the matter at the end of the Department.
- 3. The officer concerned must have been in Government service at the time when his/her junior in seniority was promoted.



4. His pay fixation shall be effected only if he is found eligible for the same upon verification of facts from his service book and all his relevant official record. He is being given deemed promotion shall be entitled to notional benefit only after his deemed promotion & he shall not be entitled for any arrears on the ground of this deemed promotion.
