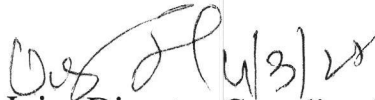

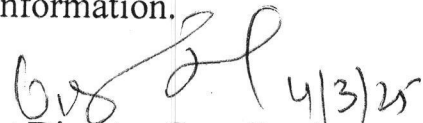

In order to facilitate efficient and speedy implementation of Budget Announcements-2025, as part of the Post Budget Consultation a series of webinars across various key sectors are being organized with the following objectives:

- e) Effective communication of the announced measures to relevant stakeholders,
- f) Obtaining inputs from the sector experts for better formulation of the policies / measures / schemes,
- g) Deliberate collaboratively on the implementation strategy, and
- h) Develop ownership of all concerned stakeholders in effective implementation.

2. 7 different themes across various Sectors have been identified for the webinars. Department of Higher Education is the lead Department along with Ministry of Skill Development and Entrepreneurship for the "Theme 4: Investing in People". In this theme 12 budget announcements related to various Ministries / Departments are covered. The Webinar for Theme 4 is scheduled on 05.03.2025 which will start with Panel discussion on theme "Invest in People" led by the key expert / stakeholders / Secretaries concerned, Parallel Break away Webinar sessions covering all 12 Budget announcements and a concluding session.

3. The Webinar will also include special address in Plenary session by the Hon'ble Prime Minister at 01:30 PM.

4. Department of Higher Education has three Budget announcements namely Bharatiya Bhasha Pustak Scheme (Para 43), Expansion of Capacity of IITs (Para 45) and Centre of Excellence in AI for Education (Para 46). Accordingly, three Parallel Break away Webinar Sessions led by the key sector expert, are being organised by the Department of Higher Education. Detailed time line of the Post Budget Webinar is attached.

5. I would request you to kindly attend Plenary session, Breakout Sessions and the Concluding Sessions of the Post-budget webinars. Webinar links of these Sessions are annexed.
