I am directed to invite your attention on the subject cited above and to say that it has been decided by the Government that the newty recruited Group-C employees are to be allowed to join at the post(s) by the Government. If the post has already been occupied by a Contractual employee of Group-C level engaged under Outsourcing policy, Part-I & II or HKRNL or otherwise by a contractual employee who initially engaged before 15th August, 2019 in any of the Organizations under Haryana Government, such employee will not be relieved and his/her case will be processed by the concerned Department/Board/Corporation for grant of benefit of security of service under the Haryana Contractual Employees (Security of Service) Act, 2024.

Government has also decided that if after the joining of newly recruited Group-C and adjustment of all Contractual employees getting benefit of security of service under the Haryana Contractual Employees (Security of Service) Act, 2024, the vacant posts are not available in the Department/Board/Corporation, then the Contractual employees initially engaged through HKRNL will be relieved by applying the principle of 'first in first out', i.e. the Contractual employee with the most length of engagement to be firstly relieved.

These instructions shall be applicable with immediate effect. This may please be brought to notice of all concerned for compliance.
