You are hereby informed that there is pendency in verification of PMS to SC/BC students at the level of Colleges and Universities (L1 and L2) regarding Scholarship from the session 2022-23 to 2024-25.

A meeting was held on 15.04.2025 under the Chairmanship of Chief Secretary to Govt. Haryana, Welfare of SC/BC Department, in which the matter of pending verification was taken up and it was instructed by Chief Secretary, Social Justice & Empowerment Department, Govt. of Haryana that pending verification should be completed urgently within three days. In this regard the department has issued many letters before this, but the pendency of verification has not been completed by many nodal officers at Institutions/ Universities (L1 and L2).
