The Governor of Haryana is pleased to promote Smt. Sunita Rani, Associate Professors of English to the post of Principal in Group-'A' (College Cadre) in Level-14 of the 7th Central Pay Commission (CPC) plus allowances admissible as per rule on provisional basis with effect from 19.12.2024 along with arrears subject to the following conditions:-

1. The promotion is without prejudice to the right of her senior.
2. The promotion is without prejudice to the disciplinary proceedings pending against seniors.
3. The promotion is further subject to Government/Court decision adversely affecting this promotion.
4. In case the vacancy against which she is being promoted cease to exist and there is no vacancy of the post on which she is being promoted, she will be reverted to her original post without any notice.
5. The promotion order is subject to the modification/Correction in case of any inadvertent discrepancy/gap that may be found at later stage.
6. She will remain on probation for a period of one year which can be extended as per Service Rules.
7. The post of Scheduled Castes category has been kept reserved to the extent of 20% as per notification No. 22/56/2023-5HR-III, dated 07-10-2023.
8. She is hereby directed to give her joining at office of Director General Higher Education Haryana, Panchkula. The promoted Principal will continue to discharge their current duties/work at their present place(s) of posting (regular/deputation) till their regular posting order is issued. If she will not give joining within 15 days from the issuance of the promotion order, this promotion shall be withdrawn/rescinded and she will not be considered for promotion for at least for one year from the date of issuance of this order as it will be treated as forging of promotion.
