**Subject: Implementation of National Youth Parliament Scheme (NYPS) 2.0 – Directions for Participation of Educational Institutions.**

I am directed to convey that the Ministry of Parliamentary Affairs, Government of India, vide D.O. letter No. NYPS/1/2024-YP dated 03.06.2025 (Copy attached) and its earlier communication dated 24.05.2024, has issued directions regarding the implementation of the **National Youth Parliament Scheme (NYPS) 2.0** through its web portal (<https://nyps.mpa.gov.in/>). The scheme aims to strengthen democratic values among students by involving them in Youth Parliament activities.

2. Under the revised framework:

- Students of Classes VI to XII may participate under the **Kishore Sabha** category.
- UG/PG students may participate under the **Tarun Sabha** category.
- Citizens may also participate individually through online quizzes.
- All recognized educational institutions: (Government & Private schools, universities, colleges, technical institutions, polytechnics, engineering & diploma colleges, and ITIs) are eligible to organize Youth Parliament sittings after registering on the portal.

3. The Ministry has requested that the programme be actively promoted and implemented across all educational institutions, and that Youth Parliament activities may also be considered as project work or co-curricular activity.

4. In this regard, I am directed to request that:

1. Necessary instructions may kindly be issued to all recognized institutions under your administrative control to register and participate in the **NYPS 2.0** as per guidelines on the portal.
2. A **Nodal Officer** may kindly be nominated from each Department to coordinate with the Ministry of Parliamentary Affairs, GoI.
3. The possibility of including Youth Parliament Programme activities as part of co-curricular projects may also be explored.
