

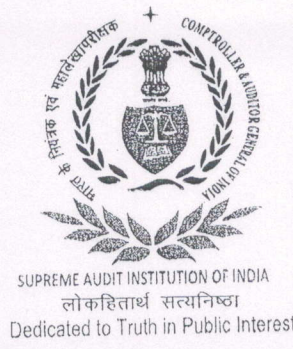

With a view to strengthening the follow-up mechanism for Audit Observations and Audit Products, a new Inspection Report Monitoring System titled “CAG Connect” is being developed by the Indian Audit & Accounts Department (IA&AD). The portal will be integrated with the One Indian Audit and Accounts Department One System (OIOS) and will enable audit entities to view pending audit observations and audit Products relating to Compliance Audit and submit their replies through the portal. The system also facilitates multiple iterations of responses between the auditee and audit, thereby improving efficiency and transparency in the process.

It has, however, been observed that a majority of the units under the **Higher Education Department, Science and Technology Department, Technical Education** are presently using non-NIC / non-Government domain email IDs for official correspondence.


