Till then, they will work at their present place of posting. As per Para XIV (4) of Model Online Transfer Policy these newly promoted Junior Lecture Assistants will fall under Notional Vacancy.

Terms & conditions:-

1. These promotion are without prejudice to the right of his/her seniors.
2. These promotions are without prejudice to the disciplinary proceedings pending against his/her seniors. In case he/she (senior) is found to be eligible for promotion at any later stage, he/she will be reverted to their original posts.
3. These promotions are further subject to Government/Court decision adversely affecting his/her promotion.

4. In case the vacancy against which he/she is being promoted cases to exist and there is no vacancy of the posts on which he/she is being promoted, he/she will be reverted to his/her original post without any notice.
5. He/she will remain on probation for a period of one year, which can be extended in terms of Service Rules.
6. In case he/she does not join the promotional post within one week, his/her promotion will stand cancelled.
7. The promotion orders are subject to the modification/correction in case of any discrepancy/gap that may be found at later stage.
8. If any official is found senior to his/her at any stage due to re-fixation of his/her seniority, he/she will be reverted without giving any notice.
9. The promotion of the above officials are subject to the final decision of the Hon'ble Supreme Court in SLP No. 31566 of 2018 and other connected SLP.
