In compliance of order dated 07-05-2022 passed by the Hon'ble High Court in CWP No. 11256 of 2022 titled as Pardeep Kumar and others Vs State of Haryana and another, the following Junior Librarians of Government Colleges, Libraries and Public Libraries are hereby promoted to the post of Senior Librarians on purely temporary and provisional basis in the UGC Pay Scale in existing pay at Rs. 6000 AGP in PB Rs. 15600-39,100 and Revised Pay at Academic Level 10 with rationalized entry pay of Rs. 57,700/- with immediate effect:-

Note:- For faithful compliance of the above Hon'ble Court order as well as in light of existing service rules, the case of petitioner, i.e. Sh Pardeep kumar, Junior Librarian has also been considered by the competent authority for promotion to the post of Senior Librarian and it emerged that he is not found eligible for the promotion to the post of Senior Librarian as he had retired on 31.03.2024 before completion of the condition of 5 year experience as Junior Librarian.

Their promotions are subject to the following conditions:-

1. Their promotions are without prejudice to the right of their seniors. In case any claim by any senior is decided/received at any stage in future, they will be reverted to their original posts from which they are being promoted.
2. Their promotions are without prejudice to the disciplinary proceedings pending against their seniors.
3. Their promotions are further subject to Government/ court decision adversely affecting their promotions.
4. In case the vacancies against which they are being promoted cease to exist and there are no vacancies of the post on which they are being promoted, they will be reverted to their original post without any notice.
5. They will remain on probation for a period of one year which can be extended as per Service Rules.
6. In case they do not join the promotional post within 15 days, their claim will be rejected as per rules.
7. The promotion orders are subject to the modification/correction in case of any discrepancy/gap that may be found at later stage.


