Subject:- Provisional appointment to the post of Assistant Professor (College Cadre),HES-II Group "B" in the subject of Computer Science.

On the recommendation of Haryana Public Service Commission, Panchkula received vide No. No. RG 18/2024/9749 dated 30.01.2026, the Governor of Haryana is hereby pleased to appoint above named candidates as Assistant Professor (College Cadre), HES-II Group "B" in the subject of **COMPUTER SCIENCE** in an officiating capacity in the pay scale of Rs. 57,700-1,82,400/- plus usual allowances sanctioned by the Govt. from time to time, on the following terms & conditions:-

1. The appointment is purely temporary and on provisional basis.
2. The appointment is against a temporary post. The confirmation against substantive post shall be considered on the basis of seniority & record of service as and when such post is available.
3. You will be on probation for a period of two years in the first instance & he/she probation period can be extended if in the opinion of the Govt. it is necessary to do so.

4. Till you are confirmed, your services are liable to be terminated at any time without assigning any reason by giving one month's notice or one month's salary or salary for such period for which the notice falls short of one month, as the case may be, in lieu thereof, and in case you desire to resign from service you will have to give one month's notice or deposit one month's salary or salary for such period by which the notice falls short of one month in lieu thereof, as the case may be.
5. You will have to take an oath of allegiance to the Constitution of India and affirm that you do not have more than one living spouse in case he/she is married.
6. In case you are married, you will have to furnish a declaration to the Head of Department that he/she will not taken/give any dowry after marriage. The declaration should be signed by you/ wife/husband, father and father in law, as per Chief Secretary, Haryana letter No. 18/1/2004-2GSI dated 21-02-2006.
7. If you are unmarried, he/she will have to take an oath of allegiance to the Constitution of India and affirm that he/she do not give or take or abet the giving or taking of dowry, or demand, directly or indirectly from the parents or guardians of the bride or bridegroom, as the case may be, any dowry, as per Chief Secretary, Haryana letter No. 18/1/2004-2 GSI dated 21-02-2006.
8. You will not be allowed to apply for any post outside the Department for a period of at least five years.
9. You are required to serve in rural area/small town for a minimum total period of five years out of which at least three years should be prior to placement in senior scale and at least two years prior to award of selection grade. He/she shall, however, be free to opt to do the service in rural area/small town for a period of five years at a stretch prior to the award of senior scale. However this tenure is subject to any amendment in the existing provision to be made at subsequent stage, if any.
10. Your seniority will be fixed in accordance with the Departmental Rules.
11. Your services will be governed by Haryana Education (College Cadre) Group "B" Service Rules, 1986 as amended from time to time.
12. In other matters, not specifically mentioned in this communication, you will be governed by the Haryana Civil Service Rules, 2016 as applicable to Haryana Govt. Employees and such orders/instructions as may be issued by the Govt. from time to time.
13. You will be covered by the "New Defined Contributory Pension Scheme" as per F.D. Notification dated 28-10-2005.
14. You are directed to join at Government College mentioned against your name, alongwith medical fitness certificate issued by the Medical Board of your respective district of domicile as constituted by the Director General Health Services, Haryana. Further, the selected candidate(s) domicile of other State than Haryana, are directed to join at their respective college alongwith medical certificate issued by the Medical Board (constituted by the Director General Health Services, Haryana) of the place where at the selected candidate(s) has/have been posted.
15. The appointment order is subject to final outcome of *CWP No. 13329/2025, 8615/25, 6455/25, 21663/2025, 19690/2025, 23048/2025 and 23487/2025* pending before the Hon'ble Punjab and Haryana High Court. Further the appointment order is subject to review on the basis of the outcome of various court case/writ petitions that might have been filed are pending in any court or may be subsequently filed.
16. After joining you are required to submit four copies of character and antecedents verification forms (Attestation Form) duly filled in within ten days either in person or through Registered post in the office of Director General Higher Education, Haryana at Panchkula through Principal concerned. The specimen of character and antecedents verification form (Attestation Form) can be downloaded from the website of Directorate of Higher Education, Haryana i.e. (www.highereduhry.com).
17. At any stage, if the certificate/s produced by you are found to be bogus or defective, your services shall be terminated. Notwithstanding anything contained in this appointment letter, your appointment is subject to condition that and if you are found unfit/unsuitable on the basis of medical report, your services shall be terminated forthwith without prejudice to any other terms and conditions.
18. You also ensure to complete your MIS/HRMS Profile in the Government College where you are being posted temporarily, so that he/she can opt for further posting in the next phase of transfer drive.
19. This posting allotted to you is temporary posting, until finalization of Online transfer drive and after completion of online transfer drive this posting may be change.

20. The original documents provided by the candidates be got verified and authenticated from the concerned issuing authority/University/Board etc.
21. These appointment orders are subject to the outcome of any CWP/Appeal has been filed or is to be filed and if the same is decided adversely, these appointments shall be affected as per the decision.
