7. They will remain on probation for a period of one year which can be extended as per Service Rules.
8. The post of Scheduled Castes category has been kept reserved to the extent of 20% as per notification No. 22/56/2023-5HR-III, dated 07-10-2023.
9. All the above Officers are directed to join their new assignment immediately and send the joining report in this Directorate through e-mail. The promoted Principals who do not give joining within 15 days from the issuance of the promotion orders. their promotion shall be withdrawn/rescinded and they will not be considered for promotion for at least for one year from the date of issuance of these orders as it will be treated as forgoing of promotion.
