2. These promotions are without prejudice to the disciplinary proceeding against his seniors. In case he is found to be ineligible for promotion at any later state, he will be reverted to their original post.
3. These promotions are further subject to Government /Court decision adversely affecting his promotion.
4. In case the vacancy against which he is being promoted <sup>cease</sup> to exist and there is no vacancy of the post on which he is being promoted. He will be reverted to his original posts without any notice.
5. He will remain on probation for a period of one year, which can be extended in terms of Service Rule.
6. In case he does not join the promotional post with 15 days, his promotion will be stand cancelled.
7. The promotion orders are subject to the modification/correction in case of any discrepancy/gap that may be found at later stage.
8. If any official is found senior to his at any stage due to re-fixation of his seniority he will be reverted without giving any notice.


