TERMS & CONDITIONS:-

- 1. Their appointment on the post of Clerk is purely on temporary basis which is liable to be abolished at any time and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to them at the present stage and in this respect, they will have to take their chance like others who have been similarly recruited, consequently, their services may be terminated without any notice.
- 2. If at any stage, they desire to resign their post, they will be required to give one month's notice or forfeit in lieu thereof their salary including allowances for one month or for the period by which the notice falls short of one month. The Directorate will give such a notice to them also, in case, it is proposed to terminate their services for the reasons other than that mentioned in Clause (1) above.
- 3. If they have not been vaccinated within last twelve months, it should be done immediately after reporting for duty.
- 4. They will be required to take the prescribed oath of allegiance of the Constitution of India.
- 5. They will be on probation for a period of two years, which may further be extended for a period of one year. In case, the work or conduct is not found satisfactory during the period of probation, their services are liable to be terminated forthwith without assigning any reason.
- 6. No TA/DA will be admissible for joining this post.
- 7. Their services can be utilized anywhere in the State/ Country.
- 8. They will not undertake any kind of higher studies without obtaining prior permission. Consequently, any kind of leave will not be granted for pursuing higher studies.
- 9. Further, this offer is subject to the condition that in case they are married, they have only one living spouse and if they are unmarried, they shall have to furnish a declaration immediately after marriage regarding non-acceptance of dowry by them to this office as per Chief Secretary letter no. 18/1/2004-2 GSI, dated the 21st February, 2006.

Further, they are not married to a person who has more than one living spouse and if they have more than one living spouse, they should justify the circumstances for that.

10. The above offer of appointment is, further, subject to the Haryana Education Department, National Cadet Corps (Group-C) Service Rules, 1991 and Amendment Rules, 2013 and all other rules and regulations and executive instructions issued or to be issued by the State Government from time to time.

They will be required to qualify the State Eligibility Test in Computer Appreciation and Applications (SETC) within the probation period of two years, extendable by one year. They shall not be entitled to earn any increment in their pay scale till they qualify the said test, failing which their services shall be dispensed with. Typing speed of 30 words per minute in English and 25 words per minute in Hindi is required to pass SETC test which would be tested on computers within the probation period of two years extendable by one year, otherwise, they will not be allowed to have annual increment until they pass this test. After passing the test, they will be allowed to have increment from the date following the day of test on which they passed the test, without payment of arrear of increment(s). Their date of increment will, however, not be postponed on account of his/ her failure to clear the test.



- 11. This offer of appointment is, further, subject to their submission of Medical Fitness Certificate within 15 days from the date of appointment, failing which this appointment will stand cancelled automatically.
- 12. They will be required to produce the original Educational, Caste and Date of Birth and other relevant certificates to the Head of Office/ NCC units concerned for verification.
- 13. They will not be permitted to apply for the post outside of the Department before completing five years of service.
- 14. They will be covered under the "New Defined Contribution Pension Scheme" as per F.D. Notification dated 28.10.2005 or any other new Scheme notified by the Government from time to time.
- 15. After joining, they are required to submit four copies of character & antecedent specimen of verification forms duly filled in within a month positively. Character & antecedents verification form is available in the office of concerned NCC Units.
- 16. That in case any candidate furnishes his claim of being higher in merit than the the recommended candidates, in that event, the junior most recommended candidates in the respective category will be ousted from the said list. Their seniority inter- se with other candidate recommended by the Haryana Staff Selection Commission will be fixed later on.
- 17. This appointment is subject to the condition(s) that if they are found unfit / unsuitable for appointment to Govt. service on the basis of Medical Report or on the basis of character & antecedent verification or getting entry into service by means of take educational, caste certificates. Their services shall be terminated forthwith without prejudice to other terms and conditions
- 18. They must submit a declaration in writing that there is no previous occasion in which they dismissed from service under any department of Government or convicted by a Court of Law or that no case is pending against they in any Court of Law.
- 19. This appointment is subject to any writ petition pending in the Hon'ble Punjab and Haryana High Court or any other court of law.

If the above terms and conditions are acceptable to them, they may submit their joining report to concerned Group Commander/Commanding Officer at the given place within 15 days from the date of receipt of this appointment letter, failing which the post will be offered to other candidate without giving any further notice to them in this behalf. No extension in joining time will be allowed.
